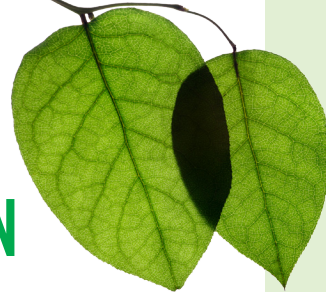

SFI IMPLEMENTATION COMMITTEES



SFI Implementation Committees are the SFI Program's strongest asset when it comes to community leadership. This grassroots network works with local conservation groups, government agencies, forestry and professional associations, landowner groups and many others to make significant community contributions through activities such as training loggers and other resource professionals and sponsoring outreach to landowners on responsible forest management.

Core priorities include:

- Logger training and education
- Responding to inconsistent practices inquiries
- Landowner outreach
- Increasing SFI program recognition
- Annual reporting
- Protecting SFI Program integrity

The committees have the freedom to develop projects, programs and activities and make decisions – within their local membership – about the best way to achieve these priorities.



IDAHO SFI IMPLEMENTATION COMMITTEE

The Idaho SFI Implementation Committee (SIC) works at the local level to promote the SFI Standard as a means to broaden the practice of sustainable forestry and ensure on the ground progress in Idaho.
